

SYRACUSE UNIVERSITY ZIMRIDE POST A RIDE SWEEPSTAKES

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. THIS SWEEPSTAKES IS ONLY OPEN TO ZIMRIDE ACCOUNT MEMBERS.

SWEEPSTAKES SUMMARY AND DETERMINATION OF WINNER: The Sweepstakes begins at approximately 12:00:01am Eastern Time ("ET") on October 1, 2015, and ends on 11:59:59pm ET on October 31, 2015 ("Sweepstakes Period"). The rules below contain other important deadlines for participating in the Sweepstakes and being eligible to win a prize.

ELIGIBILITY: The Sweepstakes is open only to legal residents of any one (1) of the fifty (50) United States or the District of Columbia (excluding U.S. Virgin Islands, Puerto Rico, and U.S. military bases outside the U.S.) who are eighteen (18) years of age or older and at least the age of majority in their state and/or jurisdiction of primary residence under applicable law and who have a Zimride account on the date of entry in this Sweepstakes. **IF YOU DO NOT MEET ALL OF THESE REQUIREMENTS, OR ANY OTHER ELIGIBILITY OR OTHER REQUIREMENTS IN THESE OFFICIAL RULES, YOU ARE NOT ELIGIBLE TO PARTICIPATE OR WIN THE PRIZE, AND SPONSOR RESERVES THE RIGHT NOT TO AWARD A PRIZE TO YOU.** Employees, agents, officers, directors, members, managers, and owners of Sponsor, are not eligible to participate or win a prize in this Sweepstakes.

Sponsor's database clock will be the official timekeeper for this Sweepstakes.

Limit one (1) entry per person and per Zimride account. Eligible user must be a member of one of the participating private Zimride networks. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, multiple Zimride accounts or otherwise may be disqualified. All entries become the sole property of the Sponsor and receipt of entries will not be acknowledged or returned. Facsimiles, mechanical reproductions, alterations, garbled, incomplete, misdirected, lost, late, mutilated, or forged entries, or entries generated by a macro, bot, or other automated means will not be accepted and are void. Those who do not follow all of the instructions, provide the required information in their entry, or abide by these Official Rules will be disqualified. Entries made by any other individual or any entity, and/or originating at or using any other web site, including, without limitation, commercial promotion subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. WINNER NOTIFICATION:
